Explanation

Unfortunately, we were unable to file the return in a timely manner, due to several issues, including the COVID-19 pandemic. Our organization provides an in-person lecture and music series to patrons in the Sarasota County community. We are a completely volunteer organization and have no employees. Because of the pandemic we were unable to provide the in-person lectures and music sessions in our regular venues. As a result, we decided to offer refunds to our patrons who bought season tickets and gave them free access to these sessions through a video-on-demand service. Since our ticketing system cannot accommodate refunds, we requested that our patrons contact us for a refund, which was then issued by check. Those requests trickled in during the fall of 2021. In order to be as accurate as possible on our tax return, we waited until late fall to prepare the fiscal yearend financial statements. The combination of the COVID pandemic, the resignation of our assistant treasurer, and the inability to train her replacement, and the holiday season, led to the delay in preparing the Form 990 for our 2020 fiscal year. I hope you will understand the challenges we faced last year and will not assess any penalties due to our late filing of the return. Thank you.
